## NOTICE OF THE ANNUAL MUNICIPAL ELECTION OF THE TOWN OF HENLOPEN ACRES

The Town of Henlopen Acres will hold its annual election on **Saturday, August 31, 2024**. The polls will be open from **9:00 a.m. until 12:00 noon** at Town Hall, 104 Tidewaters, Henlopen Acres, Delaware.

### CANDIDATES ON BALLOT

Below is a list of the four (4) candidates in alphabetical order running for two (2) commissioner seats, each having a three-year term. On election day, registered voters may vote on the ballot for up to two (2) candidates regardless of filing status.

In accordance with the Town Charter, a minimum of four (4) resident Commissioners must preside on the Board of Commissioners. A maximum of three (3) nonresidents may also serve. A minimum of one (1) resident commissioner will be elected based on the current composition of the Board of Commissioners.

### VOTER REGISTRATION

All those eligible who wish to vote in the 2024 Election must be registered to vote at Henlopen Acres Town Hall by the deadline of **August 1, 2024, at 4:30 p.m.** At the Annual Municipal Election, every person, who shall have attained the age of eighteen (18) years of age on the date of the election, and who shall be a citizen of the United States of America, and a bona fide resident of the Town of Henlopen Acres shall have one (1) vote and also, every person, who shall be a freeholder in the Town of Henlopen Acres, whether or not a resident of the Town of Henlopen Acres, shall have one (1) vote. An entity other than an individual such as a corporation, trust or partnership, shall have one (1) vote if the voter is named in a statement, signed by a person with authority; attested by the secretary and sealed, for a corporation, LLC or trust; or by all the general partners of a partnership.

### ABSENTEE BALLOTS

Absentee ballots are available from the Town Clerk and must be received at Town Hall no later than **12:00 noon on Saturday, August 31, 2024**. The deadline to request an absentee ballot packet in person at Town Hall is **12:00 noon on Friday, August 30, 2024**. The deadline to request an absentee ballot packet to be sent by mail is **Tuesday, August 27, 2024, at 4:30 p.m.**

### VOTING RESULTS

Results of the election will be posted at Town Hall by 1:00 p.m. the day of the election.
