In accordance with paragraph 15 of annex II of General Assembly resolution 70/303 entitled "Modalities for the United Nations Conference to Support the Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development", I have the honour to circulate a draft decision on the accreditation and participation of intergovernmental organizations in the Ocean Conference. The decision pertains to the accreditation of organizations identified in Note from the Secretariat (A/71/863) which is also attached for your information.

I intend to present this draft decision for the consideration of the General Assembly at the plenary meeting of the Assembly scheduled for Thursday, 20 April 2017.

Interested international organizations that were not accredited to the conferences and summits listed in paragraph 14 of annex II to Assembly resolution 70/303 may submit their application to the Secretariat by the deadline date of 15 May 2017. In this regard, please note that a subsequent draft decision will be presented to the General Assembly for accreditation of any additional intergovernmental organizations in the Conference.
